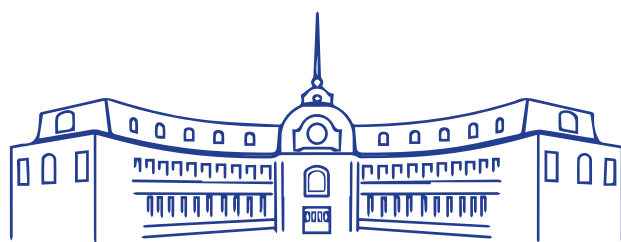

PREFACE




Open governance is becoming increasingly important in the modern world of technological progress. Global crises have further demonstrated their significance. The Supreme Council of Ajara Autonomous Republic started implementing reforms in this direction in 2020, and two years later, we have already adopted the second Action Plan.

It should be noted that the Supreme Council has increased the level of public participation in the strategic planning process. We have gone further than engaging over 10 civil society organizations in the process of action plan development and have announced an open competition for ideas on the commitments to be considered in the Plan. Young people from different educational institutions took part in the competition, and the three top ideas, selected by the public through voting on our website, belong to Batumi public school students. It is especially gratifying for us that young people are so interested in the activities of the regional legislature, especially considering that the ideas are very interesting and serve the progress of real engagement. The Open Governance Council agreed with all three ideas and reflected them in the 2022-2024 Action Plan.

The 2022-2024 Open Governance Action Plan of the Supreme Council includes three main priority areas:

- 1) Increasing public participation in the law-making process,
- 2) Engaging citizens in the oversight of the executive authority by the Supreme Council, and
- 3) Raising awareness about the Council and its activities through more transparency and various activities.



The foregoing Action Plan reflects 25 proposals from the Members of the Supreme Council, representatives of its Staff, civil society organizations united in the Consultative Group, and the winners of the open competition. These proposals, through deliberation, are presented in the form of 8 major commitments in the new Plan. Not surprisingly, open governance is an issue on which all political groups represented in the Supreme Council cooperate and make decisions based on consensus, therefore they were fully involved in the development and adoption of the action plan.

Two-thirds of the Supreme Council's first open government action plan has been fully or substantially implemented, despite several internal and external obstacles, the complicated epidemiological situation, and various political and global crises. This success did not go unnoticed by our international or local partners. The Open Government Partnership (OGP) has considered these achievements of the Supreme Council exemplary and is currently working on a wider experience-sharing at the level of regional parliaments. For us, this recognition is an additional motivation to continue the initiated reforms, strengthen the introduced practices, and achieve more real and tangible results, to further increase public interest and participation in our activities. We realize that the outcomes reached within two years are only the beginning and tireless work is still needed to involve the public in the legislative and supervisory activities at the regional body they have elected. We are proud that each of these reforms is carried out in the interest of all our citizens, inclusively, for all groups and all segments, so that no one is left behind in the process.

We hope that with the support of local and international partners, the work of the Supreme Council Staff and public participation, by 2024, Ajara will have a legislative body that is much more open and closer to society.

CURRENT SITUATION AND CHALLENGES

Currently, there are no leverages in the Supreme Council, which could improve the low engagement of society in the law-making process. At this point, there are no convenient and accessible-for-all online mechanisms to increase the interest and engagement of citizens.

The Rules of Procedure envisage public discussions on the initiated legal acts with society - in particular, comments can be made on the webpage chaerte.sca.ge. The Bureau, Committee, and Plenary sittings are also public. However, public participation in discussions is very low.

The Rules of Procedure furthermore envisage submission of a legislative proposal to the Supreme Council, a hard copy or online (via e-mail), however, there are no special modules for electronic legislative proposals on Council's web platforms (such as electronic petition).

PROBLEM SOLUTION

The Council could create more opportunities through online mechanisms to ensure society's engagement in the law-making process.

To implement the online voting system concerning draft laws; to develop an electronic draft law proposal module.

To enhance public engagement in the law-making process and develop electronic mechanisms.

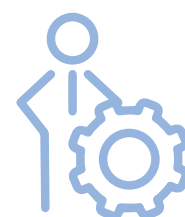

CURRENT SITUATION AND CHALLENGES

The youth is less interested in the activities of the Supreme Council.

The competitions are rarely held, which would enhance their engagement, raise awareness, and attract external knowledge.

The Supreme Council seldom offers separate activities to school pupils, however as excursions demonstrate, the interest is quite high, and such activities are required.

The 2021-2024 Strategy of the Supreme Council of the Autonomous Republic of Ajara envisages the establishment of external communication systems – the development and implementation of interactive mechanisms for public participation, and the provision of relevant feedback.

Research activities of the Supreme Council remain a challenge and research cannot be held via internal or external resources.

"Civic Education" is taught in schools in Georgia. The subject aims to develop the civil consciousness of students and to develop proper competencies in students in order for them to participate in democratic processes. Higher education institutions of the Autonomous Republic of Ajara are more or less successful in trying to use various methods for the practical implementation of knowledge in addition to theoretical teaching, however, all the resources in the region have not yet been fully utilized in this direction. It is important for the students of proper specialties to actively engage in the activities of the Supreme Council of the Autonomous Republic of Ajara, especially, in law-making and international relations.

PROBLEM SOLUTION

To enhance the youth's interest in the Council activities and increase their engagement in its decision-making processes, in particular: to conduct youth ideas and other intellectual competitions; to hold thematic meetings with students and pupils on open governance and other issues; to establish a youth committee.

Civic Education teachers and Supreme Council staff shall attend relevant training courses to improve communication with students and raise their awareness of these issues.

To enhance the interest of youth and motivate them to engage in the activities of the Council.

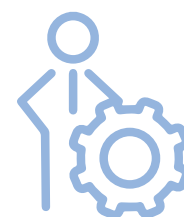

CURRENT SITUATION AND CHALLENGES

It is important to develop a long-term strategy on public participation mechanisms and their effectiveness; research should be conducted to enhance existing mechanisms of the Supreme Council, as well as to facilitate communication with citizens. Lack of communication between Majoritarian MPs and voters of the relevant district remains a challenge in Ajara municipalities. Therefore, the study should review the experience of the majoritarian system, and based on the findings, it should provide the convocation of 2024 elected through a fully proportional system with effective ways of communication with citizens.

PROBLEM SOLUTION

To conduct thorough research and to develop a long-term strategy and action plan on public participation issues.

CURRENT SITUATION AND CHALLENGES

Several sectoral committees of the Supreme Council already use in practice an important oversight tool such as thematic inquiry. Any such instrument, which is used by the Supreme Council should be regulated at the legislative level.

Global Agenda for Sustainable Development and the UN 17 Sustainable Development Goals (SDGs) are the basic means to solve modern global challenges. Despite an ambitious agenda at the national level, the works on the Global Agenda for Sustainable Development are relevant in the Ajara region. Research on the current state of affairs in the region is rarely conducted. There are no statistical data and no unified policy/strategy regarding what the regional authorities do to execute the Agenda for Sustainable Development.

Regional executive bodies do not work in the direction of Open Government Principles. There is a lack of openness and accountability at the institutional level. At this point, the Supreme Council as the representative and oversight body cannot control the observance of Open Government Principles by the executive branch, which is caused by infrequent or weak oversight mechanisms.

PROBLEM SOLUTION

A thematic inquiry which is one of the significant oversight instruments is to be reflected in the Rules of Procedure of the Supreme Council.

The Council to conduct a thematic inquiry regarding the issues of the Agenda for Sustainable Development Goals and Open Government Principles to find way more effective and inclusive ways to solve the problems existing within the oversight or law-making activities.

The Open Governance Council is to use an oversight mechanism and conduct a thematic inquiry to evaluate the situation in this regard within executive bodies. Based on the inquiry the recommendations are to be prepared to improve open government in these bodies.

The civil sector is to be engaged in thematic inquiry.

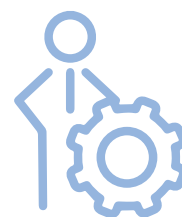

CURRENT SITUATION AND CHALLENGES

One of the most important mandates of the Supreme Council of Ajara is the oversight of the executive branch. In 2020-2022 within the scope of the first Open Governance Action Plan, numerous significant steps were made to make this process transparent, however, currently, there is no consolidated information per accountable bodies. Reports of separate bodies are provided in one section on the webpage, however, not all of them are given. There are no protocols and/or minutes of the sittings held within the scope of the oversight activity (reports presented during the Ministerial Hour, the information provided at the Committee hearings, etc.).

There are significantly few mechanisms to engage society in oversight activities of the Supreme Council. After the platform chaerte.sca.ge was launched, several days prior to the Ministerial Hour the Supreme Council started inquiring citizens regarding the questions to be asked to Ministers. And through this method the Chair of the Supreme Council asked one of the Ministers four questions received from citizens, however, this approach is not systematic; furthermore, the Minister was also not provided these questions in advance nor were they published.

PROBLEM SOLUTION

The problem can be solved through an electronic platform, chaerte.sca.ge on where several modules should be updated, in particular:

- To receive questions for the Ministerial Hour.
- To receive questions from citizens to be asked to the executive bodies, which will be periodically sent to MPs to be used in the format of an Inquiry of the Member of the Supreme Council.
- To publish documents submitted to the Supreme Council (reports, oral or written reports of the Government, Ministers, or other persons) and receive feedback from citizens about them (in the form of comments or written evaluation).

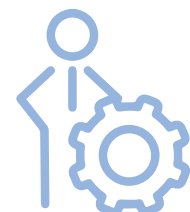

CURRENT SITUATION AND CHALLENGES

Open government, presently, is one of the basic priorities for democratic states, bearing in mind the need for technological development and modern approaches to crisis management. However, at the subnational level (regions, autonomous republics, districts, or other units) open government has not yet become the main issue on the agenda.

The Supreme Council of Ajara is one of the distinguished regional legislative bodies in the world, which started to implement the openness initiative. In a short period, the Council managed to both establish unprecedented intersectoral cooperation and to develop and successfully implement an ambitious institutional openness plan.

Ajara has numerous sister regions, with interesting experiences. Their legislative bodies have been conducting various initiatives for years, however, the practice of exchanging information in this regard between regions has not yet been institutionalized.

PROBLEM SOLUTION

The Supreme Council of Ajara has quite good experience in terms of open government reforms and can expand, enhance, and make this knowledge exemplary together with international partners. Furthermore, getting to know the practice of sister regions would allow Ajara to expand the openness scale. To this end, an international conference can be carried out in Ajara, the main topics of which can be both the institutional openness of the legislative bodies and public participation in their activities, and experience sharing of regions in terms of open governance. One of the main outcomes of the Conference should be the establishment of an international network of legislative bodies and regular cooperation.

MAIN OBJECTIVE

To hold an international conference on open governance issues together with allied regions of Ajara and with the engagement of Open Governance Partnership, to share the experience. To develop a network of regional parliaments.

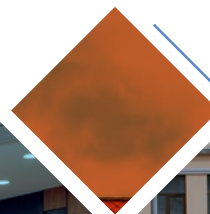
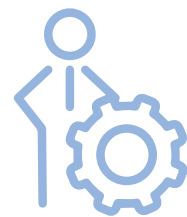
RISKS AND MITIGATIONS

RISK 2: Low engagement of regions and/or the civil society organizations operating there.

WAY TO MITIGATE: Active communication of the Supreme Council with legislative bodies of friendly regions. Enhance communication with other regions with the help of the Open Government Partnership (OGP). Active communication of the civil sector of Georgia with the civil sector of allied regions.

CURRENT SITUATION AND CHALLENGES

Little information is published regarding the partnership of the Supreme Council of the Autonomous Republic of Ajara with international or local partners. This information is general and does not reflect the specific goals, partnership forms, positive outcomes for the region, etc.

It is noteworthy, that the Supreme Council Committees do not publish protocols of sittings or submitted opinions.

Currently, the Council does not have any information subscription mechanisms, for instance, in the form of an RSS (really simple syndication) feed.

PROBLEM SOLUTION

Quite a big amount of information on draft laws is published, however, there are no opinions/conclusions. Therefore, gathering and publishing them in one space could significantly improve information accessibility.

Summarized information about partners to be added to the menu on the website of the Supreme Council of the Autonomous Republic of Ajara (sca.ge), which shall be updated annually.

RSS Feed to be added to the Council's official webpage, with the titles of materials published on the webpage, announcements, or full materials published on the website. The RSS format on the Council webpage has a bright orange image, which can easily be noticed by users to subscribe to the channel.

MAIN OBJECTIVE

Audio recordings of the committee sittings and received opinions regarding draft laws to be made public.

To raise society's awareness of partnerships with international and local partners.

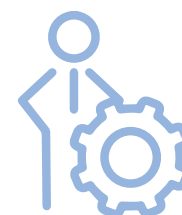

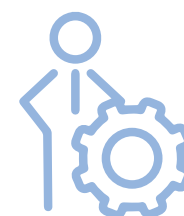
